# Introduction

The Essex Safeguarding Children Board (ESCB) learning and development programme includes courses on safeguarding children, child protection conferences and core groups, working with children with disabilities and working with resistant families and disguised compliance.

Designated person training for schools and early years and childcare settings is administered by Essex Education Services, but ESCB will continue to provide multi-agency designated person training.

# Application Process

Once you have decided on a course and date from our training brochure you must submit an online application. Submitting an application does not guarantee your place on the course, confirmation of place will be sent at least four weeks prior to the course date.

All courses now require payment information at the point of application even if they are free to attend as cancellation and non-attendance fees apply to all delegates.

Courses delivered by staff from partner agencies in Essex are generally free, however ESCB charge for courses that are delivered by externally commissioned providers; this is clearly stated on each course.

For fee paying courses- an invoice will be sent on confirmation of place on a course and it is expected that payment will be made prior to attending the course.

## Cancellation - Fee paying courses

Once a booking is made, there will be no refunds given. It is expected that payment will be made in advance of the course date. The full course fee is payable for late cancellations and non-attendance.

## Cancellation - Non-fee paying courses

Cancellation of attendance at a course with no fee and less than 15 working days' notice or non-attendance on the day of the course will incur a charge. **Charges for late notice cancellation or non-attendance are set at £50 per full day course and £30 per half day course per delegate.**

## Measuring the impact of learning and development opportunities

Your feedback from any learning and development opportunities is important to us and helps shape future opportunities.

We need to know that the learning and development opportunities we are offering are making a difference to practice. As part of this process we expect that:

- All applicants will have discussed their application with their line manager and the learning outcomes reviewed in one to one sessions. On the day of the course all delegates will complete a short pre and post course knowledge check
- They will complete the online post course evaluation that is sent approximately 4 weeks after the course
- They and their manager would be available for follow up discussions with ESCB on the difference the learning opportunity has made to their practice
- A certificate of attendance will be sent on completion of the online post course evaluation

## Measuring learning and development needs

The ESCB learning and development programme is based on the learning needs identified through local and national Serious Case Reviews, Partnership Learning Reviews, multi-agency audits and section 11 audits.

Through individual agency annual training needs assessments, gaps in multi-agency training should be identified and raised through the agency representative on the ESCB and ESAB Learning and Development sub-committee.

Further learning and development opportunities will become available throughout the year.



# Child Sexual Exploitation (CSE)

## CSE Champions- new and existing

From April 2017 Southend, Essex and Thurrock (SET) have agreed a common approach to the **role of the CSE champion**.

There will no longer be specific CSE Champions Training. In order to qualify for a CSE Champion role within Southend, Essex and Thurrock, the following standards must be achieved.

1. Have a good working knowledge of safeguarding children and have completed safeguarding children level 2 course, or equivalent as a minimum.
2. Completed a minimum of a basic awareness CSE course (online or face to face).
3. Completed the SET CSE Toolbox **On Line Training Module**
4. Have support from line management to be the CSE Champion in their team/organisation
5. SOUTHEND / ESSEX ONLY: Be a **National Working Group (NWG) member**.

You must also complete a **CSE Champions Request Form** and email it to [escb.training@essex.gov.uk](mailto:escb.training@essex.gov.uk)

These standards ensure that all CSE Champions across SET have achieved a specific level of training/development and knowledge to ensure they are able to fulfil the role expectations.

### **To maintain your CSE champions role**

To maintain your CSE Champion role each year, you will be expected to attend one CSE Champions Forum.

This will be provided by the LSCB free of charge; dates for forums will be advertised on the LSCB website and emailed to everyone who has achieved the updated CSE Champion standards.

These provide a chance to meet and network with other CSE Champions, as well as local and national updates in relation to CSE.

## CSE Learning and development opportunities

# Child Sexual Exploitation

## CSE Advanced Level Training

**Target audience:** This course is aimed at those people who are working directly with children and young people, and their managers.

**This is a CPD accredited course.**

**Course pre-requisites:** This is an advanced level training course and therefore delegates will need to already have a good baseline knowledge of CSE and its complexities- this should include an awareness of missing and the complexities of consent along with an understanding of the impact of CSE and how this may manifest

### Learning outcomes:


By the end of the course delegates will be able to;

- Identify and apply to practice the skills needed to ensure the rights of the child underpin the work we do.
- Recognise and describe how sexualised images and material can impact the lives of young people today. -
- Recognise when victim blaming occurs and have confidence in our practice to challenge this discrimination.
- Demonstrate good practice when arranging and facilitating meetings involving young people and their parents or carers.
- Explain what self blame is and how this effects young people and their emotional wellbeing.
- Define trauma and describe how it might manifest.
- Recognise ways in which we can develop our practice through the consideration of different models of working with trauma.
- Delegates will use a case study along with their knowledge and practice to analyse and question the case study in order to make an assessment and to plan how they might intervene and disrupt child sexual exploitation

To develop an enhanced understanding of safeguarding children including identifying and responding to concerns


### Learning Outcomes:

- Recognise, respond to and how to share safeguarding concerns
- Understand the safeguarding roles of parents and carers and recognise factors that may impact on parenting capacity.
- Understand the diversity of different cultural and religious beliefs when working together to safeguard and promote the welfare of children.
- Understanding and recognising the barriers for non-engagement and or non-compliance by children, young people and/or their families
- To understand how to appropriately contribute to inter-agency assessment by gathering and sharing information appropriately



- Understand how to challenge other professionals and how to escalate concerns appropriately
- Understand boundaries of personal competence and responsibility; know when to involve others and where to get advice and support.
- Be able to communicate effectively and develop working relationships with other practitioners and professionals, children and families to safeguard and promote the welfare of children.
- To have a working knowledge of the current SET Procedures & Working Together 2015
- To have a clear understanding of how families can access support across all levels of need
- To understand how to communicate effectively with children and young people
- Know how and when to consult with a safeguarding lead or designated safeguarding officer
- Being an effective advocate for children and families ensuring that the child's wishes and feelings are taken into account at all times
- Be able to evidence their assessment of need using the [Effective Support for Children and Families in Essex](#)
- To be able to document concerns in a manner that is appropriate for safeguarding/child protection and legal processes

# Safeguarding Children

## Role of the Designated Person/ Lead for Safeguarding (Level 3)

**Target audience:** This is a one day multi-agency programme for those who are the designated person/lead for safeguarding children within their organisation. This includes all agencies that are not education establishments.

### Learning outcomes:

- To understand the role and responsibilities of the designated/lead person
- To understand the legislative and good practice requirements for safeguarding children
- To understand what safeguarding arrangements should be in place to keep children safe
- To understand what to do if a safeguarding concern is raised and how you can support staff to recognise these
- To have the opportunity to reflect on current practice and make changes to better safeguard children and young people

**Target audience:** For those working directly or wanting to improve their understanding about working with children with disabilities


The course will cover:

# Prevent training- Workshop to raise the awareness of prevent-WRAP

## Cost to participants:

WRAP is the Home Office programme on Prevent. This workshop will explain the purpose of Prevent, the process of radicalisation, how to identify when someone may be vulnerable to radicalisation, how to raise concerns and what a proportionate response looks like

# Working with Resistant Families and Disguised Compliance

## Target audience:

Experienced workers across the children's workforce who, having been trained in recognising child protection concepts through e-learning or classroom training, get the opportunity for a facilitator led in-depth discussion and analysis of the key aspects of phenomena such as disguised/false compliance, avoidant or resistant behaviour of families/carers.
